Course Description

Interdisciplinary introduction to the origins of Black feminist theory and recent developments in the field. Emphasis is placed on U.S.-based thinkers. Possible topics include motherhood, labor, and representation.

- O Describe how and why Black feminist theory emerged as a field of study.
- o Analyze Black feminist responses to various systems of power.
- o Explain the significance of at least one key issue in the field in depth.
