COURSE GOALS AND OBJECTIVES

The goal of this course is to examine leadership concepts in general, and for women in particular. Covers leadership strategies in a historical framework, leadership dilemmas in various industries (locally and globally), and experiential and case-study based leadership.

Students who successfully complete this course will be able to:

- Analyze and use key terms and concepts in leadership theory.
- Gain awareness of the value of strong leadership in knowledge-based economies.
- Connect knowledge about leadership theory to different workplace contexts, industries, and nationalities.
- Analyze how gender can both facilitate and disrupt opportunities for leadership.
- Use leadership theory and analysis of gender to articulate key areas for professional development.

Module Quizzes = 150 points

There is a syllabus quiz (15 points) and 4 Module Quizzes (M 2, M3, M9, M12: 45 points each). The lowest quiz will be dropped. Module Quizzes cover all assigned readings for the module (i.e., online articles) as well as the Online Course Content.

Professional Development Activities = 400 points

There are three Professional Development Activities throughout the course. Each 1/3 of the course will include a Professional Development Activity assignment that involves analyzing theoretical and scholarly concepts and communicating how these concepts translate into professional applications.

Discussion Boards = 300 points

There will be an introduction discussion and eleven module discussions. For each module, students are required to participate in a discussion board within their small group, by submitting: At least one original substantive post, at least one response to posts, and original posts are due prior to response posts to ensure that original posts are available in a timely manner for other group members' responses.

Module Assignments = 150 points

There are two module assignments that correspond to the content of the module. In Module seven, students have a "Personal and Professional Growth" assignment worth 50 points. In Module fourteen, students will build a resume worth 100 points.
